

MISSION & OBJECTIVES

D.A.V. College Chandigarh was founded in 1958, when the city of Chandigarh was in its infancy. The college has grown with the city, becoming an integral part of the region's socio-cultural milieu. The college belongs to the family of the famous D.A.V. institutions, founded by Mahatma Hans Raj, and inspired by the great visionary-Swami Dayanand Saraswati-the doyen of the Arya Samaj, who believed that, "True education consists in promoting knowledge, civilized manners, virtuous character, self-control and other moral qualities and in dispelling ignorance". He had always felt that the scientific knowledge of the west needs to be absorbed in the cultural milieu of India. The DAV movement, which started in 1886, gives a practical shape to the ideals of Swami Dayanand's educational philosophy, which aims to develop a modern scientific approach among the students, coupled with an understanding of their roots in the ancient Vedic Culture. The D.A.V College, Chandigarh is trying to bring about this synthesis by imparting to the students the best of new world humanistic, scientific and technical knowledge with the sense of history of their rich cultural heritage-the Anglo and Vedic values. We work to achieve these broad objectives.

The college was built from scratch with missionary zeal. Brick by brick, the early principals and teachers at the college put in marvelous individualistic efforts to launch the college. And those among the student's who saw the college come up, knew exactly, what the growth had entailed. They experienced first hand sense of self less labour and love, and of duty and discipline, which had gone into the making of the institution. Intriguingly, it is this reason that makes many of these old students, themselves occupying high places and positions, come back to the college for educating their progeny. They believe that they have acquired the skills and values ingrained in them, which helped them to succeed in their lives, in this institution. They not only remember their college for its academic excellence, its committed faculty and dedicated principals, but also for its ever-growing impressive infrastructure and star sportsmen, and its rich ambience of other co-curricular activities.

DISTINCTIVE FEATURES

Every student enrolled with us is allowed perceptive freedom to excel in his or her chosen field of endeavour and interest. That is one reason, we believe, has helped us in moulding career of some of the best young men & women of this region. The offering of maximum facilities to the students so that they fulfill their potential has been the hallmark of the college. All incentives in the college, be they in the form of special coaching or counselling, extra books, sports equipment, fee concessions, stipends, scholarships, etc. have not really to be applied for. They are theirs by exhibiting the potentials for excellence in the field of academic, extra-curricular and sports activities.

The infrastructure and student support facilities available in the college have enabled us to remain on top in the region. Our students continue to bag top positions in studies. We have successfully launched Postgraduate programs in Commerce, Biotechnology, Chemistry, Mathematics, Physics, Zoology, English, Economics, Psychology, Public Administration, Sociology and P.G. Diplomas in various fields.

The college has earned respectable name in the field of sports. We have produced 69 International Sportsmen & Women like the legendary Kapil Dev, Yuvraj Singh, Yograj, Dinesh Mongia, Jeev Milkha Singh, Irina Brar and Anjum Moudgil. This tradition is alive and kicking even today. Young scholars, inspired and fired by glowing examples of their predecessors, do their best to maintain the high levels of excellence year after year that are very rarely achieved elsewhere. When they come here, success is only a sacred word in their prayers; when they leave, success is actually a solid weapon in their hands. With this weapon they proceed further to win all battles of life.

The coloured achievements of the college in the field of education, cultural activities and sports have enabled us to play host to four Vice-Presidents, one Prime Minister, several Union Ministers, Governors, Chief Ministers, great religious Leaders and other dignitaries. They have graced our functions on many occasions to bless and motivate the students and staff.

DEVELOPING THE VIRTUAL CONNECT

The global pandemic caused by the COVID 19 has made the internet-based education (e-learning) the most effective and operative way for the delivery of the educational content to fulfill the relevant academic needs of the students and provide them a resilient academic environment. To accomplish this, the College curriculum scheduled for the academic session, an Online Teaching and Learning Strategy framework was built to provide effective and individualized instruction for all students. Online classes by using Meet, Zoom, WebEx were successfully being undertaken by the faculty members. The ICT tools and resources like G-Suit - which includes Gmail, Calender, Classroom, Drive, Docs, Sheets, Slides, Forms, etc. were used by the teachers. Developing the skill to use Google classroom, Online quiz using quizizz.com and YouTube Channels has strengthened the bond between the students and the teachers. Course-specific Whats-App groups were created to facilitate the teaching learning connect.

In order to keep the students engaged in the learning process and to encourage a holistic development of the students beyond the regular classroom teaching, D.A.V. College took the initiative to start series of live web-based webinars for its students across academic disciplines. These online webinars organized by the different departments, permitted a free flow of ideas from experts, and are increasingly popular among the students as well as faculty.

SOCIAL COMMITMENT

A practical demonstration of our students' attitude can be seen in the love and concern they develop for their country and their community. They actively imbibe the spirit of social service and many of them join the armed forces. We have dedicated our Administrative Block and named it 'Shaurya Bhavan' in memory of the martyrs from our college. The idea of service to the community and the nation is reinforced through the homage that is paid to the martyrs at their memorial in the college before the start of any function by all dignitaries visiting the college from time to time. Our students actively involve themselves in programs like Blood Donation, Drug-de-addiction, AIDS awareness, Pulse Polio Campaign and service to the blind, etc. We have also joined a project to give shelter to street children. We have been holding computer literacy classes for senior citizens of the city for free. More than 500 senior citizens have benefitted so far by this initiative.



EQUAL OPPORTUNITY CELL

This Committee has been constituted to extend help to the differently abled students studying in our college. The Cell explores various possibilities to take care of the urgencies and needs of the differently abled students of the College. This College

endeavors to help the differently abled students develop their personality to the full and be a part of the mainstream.

The Committee has constituted a special cell in the name of 'Lead kindly light', which shall act as a mediator between the pool of volunteer writers and the visually impaired students to help the latter write their college as well as University exams.

TEACHING/LEARNING AND EVALUATION

The college enjoys its enviable position because of effective teaching-learning and evaluation processes. Students are provided appropriate counselling at the time of admission and offered admissions purely on the basis of their past academic performance. Their growth, skills and attendance in class are regularly monitored and their parents are kept posted with their wards' performance. A system of continuous assessment and appraisal of students has been introduced.

The courses set by the University are covered intensively with the help of all available teaching aids in the college. The faculty use computers/ multimedia/ audiovisual aids to make lectures interesting. A variety of teaching methods combining the traditional lecture with laboratory-based practical, tutorials and seminar teaching, wherever required, are employed. Term wise teaching plans and unitized syllabi help the students/ teachers gauge their performance and progress. Subject related quizzes, contests, etc. are arranged to monitor students' reading, and for creating interest in and awareness of the subjects. All departments have their own subject societies for arranging extra-curricular activities. All students are encouraged and trained to develop one or the other interest as a hobby. Their participation in such activities is duly rewarded accordingly.

RESEARCH CELL

DAV College is one of the few colleges in the country, which has established a Research Cell for the purpose of promoting research temperament and culture among students. The college has been allotted four research centre's in Chemistry, Zoology, Bio-technology and Physics. The college was granted Rs 1.5 crore by FIST for creating requisite infrastructure to carry out quality research in the college. In 2020-21, DST-FIST in continuation with the earlier grant, also accorded a sanction of Rs. 45 Lacs to the college for the creation of Capital Assets for equipment. Several major and minor projects are sponsored by the U.G.C. and other funding agencies which the faculty has undertaken. The faculty has to its credit 6 Major and 3 minor ongoing projects sponsored by UGC, Department of Science and Technology, Science and Engineering Research Board and Department of Biotechnology.

Effort has been made by the college to promote research among the students also. We have established the latest, state-of-the-art laboratories to enable teachers to guide students in their research work. The College boasts of 71 research scholars who are being supervised by faculty members of the college for their Phd under Panjab University.



Patents

An Indian Patent No. 353927 have been granted to Dr. Kakoli Biswas, Associate Professor and Head, Department of Biotechnology for her inventions on "NOVEL MEDIA FOR PLANT TISSUE CULTURE" on 12th December 2020, the research for the same was carried out in DAV College, Sector-10 Chandigarh. This individual patent opens up avenue for low cost medium that reduces the cost of tissue cultured plants at the commercial level.

Dr. Harmunish Taneja (Department of IT) and Dr. Kashma (Department of Chemistry) have applied for patents as well.

Research Consultancy

A research consultancy project of Rs. 2.5 lakhs had been signed between Dr. Kakoli Biswas and Amulya Herbs Pvt. Ltd in 2019. Under this project Dr. Kakoli checked the Bio Quality Assurance by performing DNA fingerprinting of the herbs used in the herbal drug industry. This is the first-ever consultancy service in the history of DAV College and in the City where Academia

and Industry collaboration has been started. Dr Raghubir Singh form the Department of Chemistry also got a consultancy project from Ashavin Labs, Industrial Area for the synthesis of different pharmaceutical molecules for a duration of 1 year worth 1 Lakh.

A MOU was signed between DAV College Chandigarh and CIBioD (ICMR- Centre for Innovation and Bio Design) Post Graduate Institute of Medical Education & Research (PGIMER), which will help our student to undertake translational research and summer training at PGIMER research laboratories. The innovative ideas of our faculty and students will shape up into progressive research in the field of medical science.

CENTRAL INSTRUMENTATION LAB

DAV College Managing Committee along with the grant of Department of Science and Technology, Government of India has started an Instrumentation Lab in College Campus. In this instrumentation lab, various instruments like HPLC system, Electrochemical workstation, Inverted microscope, Gradient PCR, Gas Chromatograph, Digital Polarimeter, UV-Vis. spectroscopy, FT-IR, Ultra pure water purification (HPLC grade) and Flourescence spectroscopy are available for all institutional and industrial research purposes.



DAV COLLEGE: SWAYAM - NPTEL LOCAL CHAPTER

DAV College Chandigarh was established as SWAYAM - NPTEL Local Chapter in the year 2019.NPTEL, the National Programme on Technology Enhanced Learning was initiated by seven Indian Institutes of Technology (Bombay, Delhi, Kanpur, Kharagpur, Madras, Guwahati and Roorkee) along with the Indian Institute of Science, Bangalore and aims at providing open online courses along with certificates from the IITs/IISc upon successful completion. It has the largest online repository in the world in the courses of engineering, basic sciences, humanities and social sciences subjects. NPTEL website has its own Youtube educational channel, more than 56000 hours of video content, 52000+ hours of transcribed content along with 51000+ hours of subtitled videos. The objective of enabling students to obtain certificates is to enhance their skills and making them employable in the industry. There are large number of 4-, 8-, or 12-week courses that are relevant to students in enhancing their skills along with basic core courses in sciences and humanities with exposure to relevant tools and technologies. The enrolment to and learning from these courses involves no cost. However, after successful completion of the course, students have a choice to appear for certification exam by paying nominal fees and obtain a certificate through the participating institutions and industry, when applicable.

Dr. Meenakshi Bhardwaj, Associate Professor and Head of Department (CS&IT) has been appointed as Single Point of Contact (SPOC) for NPTEL- Swayam programme. As local chapter of NPTEL, we at DAV College motivate and guide students to enroll in relevant courses every semester and encourage inter-disciplinary approach towards learning. Students from the college as well as other areas are guided regarding course selection, applying for certification and any other issues they face during the course. Any student can enroll for these programmes and DAV College as a local chapter helps them with all the latest details regarding courses, assignments etc. Moreover, the college also assigns mentors for various courses who are in close association with the enrolled students in case they face any difficulties. More than 260 students and faculty members have enrolled in various courses since 2019.

RUSA

RUSA provides grant to the college for improving and renovating the existing infrastructure (construction and renovation), purchase of equipment's, conducting Faculty Development Programmes and undertaking other research activities.

SKILL DEVELOPMENT CENTRE

The College is among the forerunners in running UGC Skill Based courses successfully. The College has established a Skill Development Centre in separate building named 'Swami Dayanad Saraswati Saksham Kendra' in August 2014 exclusively for UGC sponsored B.Voc. and Community College Courses. The college had been successfully running four skill courses under UGC Skill Based Education under NSQF.

The Journal DIVINER publishes research based articles/ papers contributed by research scholars and teachers in India and abroad. It is being published successfully since its inception in 2004.

The College magazine '*Nirmata*' is run by an Editorial Board consisting of members of the staff and students who have a flair for writing. It gives an opportunity for self expression to the students in Sanskrit, Hindi, Punjabi and English.

PLACEMENT CELL

The DAV College, Chandigarh has a fully functional Training and Placement Cell in place, which is committed to providing all possible assistance to its students pursuing various degree, diplomas, vocational courses in finding good employment opportunities. The placement cell is headed by a Coordinator (appointed from among the faculty members) and aTraining and Placement Officer ably supported by student placement coordinators from various departments. The Training and Placement Cell at DAV College, Chandigarh is active throughout the vear for the facilitation of contacts



between recruiters and students. It arranges pre-placement lectures on communication skills, soft-skills, group discussions, personal interviews, resume-writing etc. for honing the capabilities of students. Both on-campus and off-campus interactions with the recruiters are facilitated regularly. The Cell also invites industry professionals to interact with the students in order to identify the emerging opportunities in the corporate world. An Annual Placement Drive is held every year in the months of February/March/April wherein leading recruiters come to the College campus to hire students. Driven by a mission that almost every degree holder gets a job offer in hand while exiting from the college, the Training and Placement Cell steadfastly endeavors to provide skills and opportunities to students in line with their competencies and to help find the best fit as per their requirements. The Training and Placement Cell has recently acquired a software called Calyxpod that allows for database generation of student resumes, sending of customized notifications to the students and sharing of their details with the recruiters. The students can also use the software as an Android app on their smartphones.

Some of the companies which offered placements this year are enlisted as:-

Deloitte, D.E.Shaw group, LT Foods, Ernest and Young, Quik Relation, Infosys, Tutor eye, Wipro, eClerx, Focus, Edumatics, ICICI Prudential Life Insurance, Zscaler, South Indian Bank, Whitehat junior and Dialabank. These companies offer a package between 1.80LPA to 19.25 LPA. Six students of our college have been selected by South Indian Bank for a Pay Package of 4.63 LPA + other benefits + medical benefits 3 LPA.

INFRASTRUCTURE

Our greatest advantage is that the college is located in the heart of the city and is easily accessible to commuters from outside as well as to the ones from different sectors of the 'City Beautiful'. We have a huge building with spacious classrooms, sprawling lawns, a beautiful seminar complex with audio visual aids, two auditoriums, 27 sophisticated labs, Language Lab, Smart classrooms and vast playgrounds. Facilities such as State Bank of India ATM, a Cyber Cafe, Photocopy Shop, Phone Recharges, Bookshop, General Merchant Shop, Fruit & Juice Shop, Cobbler Shop, Dry Cleaner, Coffee House, Nescafe vent, Canteen, well equipped Gymnasium and Beauty Parlour for Hostel Girls are also available on the campus.



A doctor remains on duty in the college dispensary to attend to the minor ailments of staff and students.

HEALTHY PRACTICES

The College attempts to cater to the special needs of all students in various ways. It organizes remedial classes and makes special arrangements for advance learners. It provides an environment which facilitates learning.

Ragging, drinking and smoking are prohibited on the campus. Musical concerts, which encourage vulgarity and obscenity, are not allowed in the college. Anti-drugs, antiviolence and anti-alcohol programmes are organized by the active participation of the Students' Central Association. The students are only allowed two wheelers on the campus so that they realize the need of observing some austerity, and also contribute to the conservation of natural resources. Our endeavour is to produce sensitive and successful humans in tune with the demands of modern times.

WASTE MANAGEMENT

The college has well established Waste Management Society which takes care of cleanliness and utilization of organic waste in the campus. Waste management committee has been actively involved in waste management in the college campus. In the hostels composters are installed to convert organic waste like; vegetable- peels, left-over food etc. into compost, which is utilised in the college campus. It is eco- friendly and an ideal method of disposal of wet waste. To make the students and faculty aware regarding the impact of dumping of waste in the surroundings and the methods of disposal, which can be manageable at home by every individual, webinars, workshops, rallies and seminars are organized by the society. More over for hygienically disposal of used sanitary napkins electrical machine has been installed in the campus to make it pollution free.

GRIEVANCE REDRESSAL COMMITTEE

Our institutional ethos is centered on the broader human values of justice, equity and dignity and to implement these principles we have a Grievance Redressal Committee in the college. The committee takes up all issues including those of complaints of alleged discrimination of students on the basis of caste, colour, creed, region, religion or disability. A grievance box is also set up in the college for complaints, which are addressed by the Committee constituted for its redressal.

COMMITTEE AGAINST SEXUAL HARASSMENT

The College ensures that all Students, faculty, Staff, Karamcharis and Officials treat one another with due respect and that the institution remains a healthy and safe seat of work and study bereft of any kind of sexual harassment, unwelcome sexual advances, requests for sexual favours and other visual, verbal or physical conduct of a sexual nature. 



- 2. All the admissions to these institutions are provisional and subject to the approval of the Panjab University. The institution cannot be held responsible in case the University does not approve the admission of a student on account of giving incomplete information, concealing necessary facts or attaching incomplete testimonials or choosing wrong combination of subjects or delayed submission of certificates etc. The fine/penalty imposed by Panjab University for any default in this regard shall be the personal responsibility of the student.
- 3. All candidates found eligible for admission will have to appear in person before the Admission Committee on the dates notified in the prospectus. A candidate who does not attend the interview shall not be admitted.
- 4. Students disqualified by any University/Board shall not be admitted.
- 5. Concealment of facts/furnishing of false information in the Admission form will lead directly to the cancellation of admission and the amount deposited as fee will be forfeited.

7. Late Admission

a. Permission of the Vice-Chancellor is necessary for admission after the expiry of the last date for admission given with the Principal's permission.

b. A student, whose result of 10+2 examination has not been declared by the School Board, may be admitted without late fee within 15 working days of the declaration of the result, depending upon the availability of seats and the fact that the Admission Form has been submitted as 'Result Awaited Case' before the last date of submission of Admission Forms. The attendance of such a student shall be counted from the date of admission. This would be applicable to Open School also. After expiry of this period, late admission approval from the Vice-Chancellor is required.

c. In case of late declaration of result by Panjab University, normal admission will take place within 10 working days of declaration of the result. This rule will not apply to a candidate who passes the lower examination from any other University/Board.

8. Re-Admission

a. A student who remains absent for more than ten days at a stretch, including 19 holidays, in one or more than one subjects/periods, without sanctioned leave is liable to have his/her name struck off from the college rolls.

b. If a student's name is struck off from the college rolls, he/she will be required to seek re-admission within 10 working days failing which his/her admission will stand cancelled.

c. Re-admission fee will be charged. It is mandatory for the student to bring his/her parent at the time of re-admission.

d. Re-admission is not the right of every student. It is the prerogative of the Principal of the respective college and it is allowed for not more than two times per semester/per session.

Candidates Require Migration Certificate When:

- a. They are not from Panjab University.
- b. No migration will be permitted to a student with a combination of Subjects not provided in these colleges.
- c. Mid-term migration from any other university is not allowed.
- 10. Deficient Subjects A candidate who has passed his/her 1st and 2nd Semester of B.A./B.Sc.(General)/B.Com/ B.B.A./ B.C.A. course conducted by another University/College affiliated to another University in India under specific authorisation by the University concerned, be allowed to migrate to a College affiliated to Panjab University/Department of evening Studies/University School of Open Learning in the 3rd Semester/5th Semester of the respective Course (as per rules prescribed under Chapter XIV- "Migration of Students' Page No 247 to 262 of P.U. calendar Volume-III, (2009) on

the condition that such a candidate will have to clear the Deficient Subject/s if any, within the permissible chances. Deficiencies should be determined by the Principal/Chairperson at the time of admission under intimation to University (i.e. on the registration Return and examination forms) as well as to the students as per University rule No.6 given at Page 261 of P.U. Calendar. Vol.III, 2009.

- a. A Candidate seeking admission to any college after migration from Universities other than the Panjab University shall clear deficient subjects, if any, as determined by the College/University.
- **b**. Deficient subject is one which is not passed by the candidate in the previous institution in that class and is required to be qualified for admission to next higher class.
- c. The candidate should be asked to furnish the details of the courses he/she has covered in his/her previous institution, i.e. course contents etc. And that should be certified by the Principal/ competent authority of the previous institution.
- d. In case of students who have passed their B.A./ B.Sc./ B.Com./B.B.A./B.C.A. part I/II examination from Universities other than those from the Punjab State there should be no deficient subjects. In case the student had covered more that 50% of the syllabus prescribed by the Panjab University in a subject it shall not be treated to be a deficient subject.
- 11. Foreign Students All Foreign Students shall obtain Eligibility Certificate from Deputy Registrar (General) Panjab University in all cases and the admission of the foreign students to College/Teaching Departments would be governed by the Guidelines issued by the Dean Foreign Students. The eligibility form should be accompanied by a forwarding letter from the Principal of the College/ Chairperson of the Teaching Department indicating the reason for denying the admission to the candidate. After obtaining the Eligibility Certificate, the candidate should submit the same to College/department where he/she is seeking admission.

CHECKLIST OF DOCUMENTS FOR FOREIGN STUDENTS

- 1. Original Passport/Visa. (Wherever applicable).
- 2. Valid Student Visa.
- 3. A certificate of registration from the local police.
- 4. Date of Birth Certificate with the Father's/Mother's name.
- 5. An eligibility certificate from the Panjab University to desired course.
- 6. Original letter of certificate from present institution.
- 7. Original Migration Certificate.
- 8. Academic certificates and testimonials.
- 9. Original letters of scholarships in case of those who are Government of India sponsored scholars. The respective college authorities have the right to reject any admission form and refuse admission if there is any discrepancy in the name, date of birth or even spellings of the names in passport, certificates, testimonials and birth certificate etc.

Reservation Policy

Students are admitted to the college on the basis of merit and an interview conducted by the Admission Committee. Candidates must present themselves for the interview at the time of admission. Candidates who do not appear for the interview will not be considered for admission. The candidates must produce all the relevant certificates in original for the verification at the time of interview failing which they will not be considered for admission. The college reserves the right to refuse admission to any student without assigning any reason.

The students seeking admission on the basis of having passed their lower examination from Board/University other than Panjab University are advised to submit their original Migration certificate and marks sheet at the time of admission. Marks would be verified from the Result Gazette.

For admission, fraction of marks less than the requisite percentage would not be rounded off to the advantage of the candidate i.e. 32.9%, 39.9% and 49.9% shall not be rounded off to 33%, 40%, 50% etc. The college is not responsible if the university does not approve of the admission of a candidate who has made some wrong or incomplete statements, hidden some necessary facts, or attached false or incomplete documents. All admissions made are subject to approval of the Panjab University, Chandigarh and according to eligibility criteria laid down by it.

Reservation of seats in different categories viz, Scheduled Castes, Scheduled Tribes, Dependents of Defence and Paramilitary Personnel, Freedom Fighters, Physically Challenged and Sports will be made in accordance with the rules and instructions framed by the Chandigarh Administration, whereas in case of Single Girl Child, One out of Two Girl Children, Kashmiri Migrants, Kargil Martyrs, Cancer/AIDS/Thalassemia, students from Jammu & Kashmir, Border Area, Rural Area will be made as per instructions issued by Panjab University from time to time.

IN MAKING ADMISSIONS

- $1. \quad \text{All the affiliated colleges of Chandigarh} (U.T.) \text{ shall follow the reservation policy of Union Territory Administration}.$
- 2. All affiliated colleges of Punjab State shall follow the reservation policy of the Punjab Government. Any student who applies in more than one reserved category will be considered in each reserved category in which he/she applies for

admission, maintaining his/her internal seniority in each reserved category on the basis of merit in that category. In such a case, the student will get the benefit in one category of his/her choice.

As per letter no. 19/1/93/IH (3) 5311 dated 18th March, 1999 from Home Secretary, Chandigarh Administration, the following policy shall be followed w.r.t reservation of seats: In continuation of this Administration's circular letter no. 19/1/93/IH(3-99/11136) dated 9th June, 1999 on the above subject, which inter alia provides that 85% seats of the total sanctioned intake of an institution will be filled up from amongst the students who pass their qualifying examination from schools/colleges recognized by the Chandigarh Administration and situated in the Union Territory, Chandigarh, as regular students of the said school/college, which will be termed as UT POOL. The remaining 15% seats will be filled from amongst students, who pass their qualifying examinations from institutions other than those located in the Union Territory, Chandigarh or otherwise, which will be termed as GENERAL POOL.

Note:

- i. UT Pool Candidates: Those who have passed lower qualifying examination as regular candidates from schools and colleges in UT, Chandigarh.
- ii. General Pool Candidates: Those who have passed lower qualifying examination from schools and colleges outside UT, Chandigarh.

A. Reservation of Seats. The reservation is out of 85% seats of UT Pool and 15% seats of General Pool.

Note: Amendment, if any, in the reservation policy of Chandigarh Administration/Panjab University will be followed upto the date of admission for each course.

*According to the letter vide Home Department, Chandigarh Administration order no. 19/1/3-IH(3)-2008/20352 dated 27/10/2008, endorsed by DHE vide no. 2778-dhe-ut-c5-26(i)92-II dated 6/11/2008, it has been decided to consider the wards of serving defence personnel/ex-servicemen i.e. sons/daughters, under 85% quota only for calculation of seats.

B. Reservation for the Dependents of Defence / Para-Military Personnel etc. is on the following priority:

- I. Sons/daughters/spouses of Defence Personnel who are awardees of gallantry decorations of ParamVir/ MahaVir/Vir Chakra in person or posthumously.
- ii. Sons/daughters/spouses of Defence Personnel/Para-Military Personnel like CRPF and BSF who were killed or are totally incapacitated in action while in service and are wholly dependent on them.
- iii. Sons/daughters/spouses of ex- servicemen (Defence/Para-Military Personnel) who are wholly dependent on them.
- iv. Sons/daughters/spouses of serving persons (Defence/Para-Military Personnel) who are wholly dependent on them.

Refer to Panjab University letter no. 7751-7780/Misc. /A-6, dated 14-8-2003. Policy regarding reservation of seats in admission to educational/technical/medical institutions under the control of Chandigarh Administration - amendment thereof: "For the purpose of reservation to the category Para-Military Forces, wherever applicable, this category shall include wards of personnel serving in the Intelligence Bureau, National Security Guards, and Special Services Bureau at par with the wards of employees of other Para-Military Forces, in consonance with the circular issued by Government of India, Ministry of Home Affairs, no. 27011/9/98- PF-I dated 26-5-1998."

C. Reservation for Physically Challenged

The physically challenged student will be required to furnish a medical certificate issued by the Principal Medical Officer of his concerned district/Civil Surgeon of Chandigarh, indicating percentage of disability, whether he/she is otherwise able to pursue his / her studies, name of the disease/handicap, whether the handicap is temporary or permanent; and whether the handicap is progressively degenerative.

5% marks concession will be given to physically handicapped persons in the minimum eligibility criteria for a course subject to minimum disability of 40%, provided they have obtained minimum pass marks prescribed by regulations.

Students with a temporary handicap will not be considered against the reserved seats for the physically challenged. Where the certificate is issued by any authority other than the Principal Medical Officer of Chandigarh, the concerned Head of the institution shall refer the candidate to the Principal Medical Officer, Chandigarh and shall admit the candidate only after confirmation from the PMO, Chandigarh.

All candidates seeking admission, except in the case of Chandigarh Medical College and Punjab Engineering College (where the existing practice shall continue), will furnish an undertaking, as under, along with their application form: I certify that I have no such physical handicap/disability which would hinder the pursuit of studies in the course in which I am seeking admission. If at a later stage it is found that I have a physical handicap/disability which hinders the pursuit of studies in the course in which I am seeking admission, then my admission will be liable to be cancelled.

In case of any doubt in interpretation of any clause of these instructions, the matter shall be referred to the Chandigarh Administration whose decision shall be final.

D. Reservation for Wards of Freedom Fighters

2% seats in each pool will be filled from the category of children and grandchildren of Freedom Fighters. A certificate issued by the Deputy Commissioner of the concerned district will have to be attached with the admission form.

E. Concession to the Wards of Kashmiri Migrants / Displaced Persons.

As per letter No. Misc./A-6/59801-60001 dated 22.04.2015 from the Deputy Registrar Panjab University: As conveyed vide letter no. D.O No. F 1-13/2010 CPP-II dated 19th March 2015 from University Grants Commission and letter No. F. No. 3-1/2012-NER dated 12th March 2015 from Govt. of India, Ministry of Human Resource Development, Department of Higher Education, Shastri Bhawan, New Delhi with regard to the concession to the Kashmiri migrant for admission in Higher Education which are read as

- i. Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement.
- ii. Increase in intake capacity upto 5% course wise.
- iii. Reservation of at least 1 seat in merit quota in technical/professional institutions.
- iv. Waiving off domicile requirements.

F. Concession to the Wards of Permanently Disabled and Martyrs of Kargil War

- a) Reservation of 1% seats with minimum of 1 seat in the Departments and affiliated colleges except in partially financed/self-financing courses.
- b) Exemption of Fee.
- c) Exemption of Hostel Fee. (vide Syndicate Para 30 (XI) dated 29-) 7-08. for the direct descendants of the Kargil Martyrs/permanently disabled (up to 80% leading to incapacitation) as per letter no. 6576-6875/R & S, dated 27-05-2014 received from the Panjab University.

G. Reservation for Single Girl Child/One Girl Child out of the only Two Girl Children

As per decision of Panjab University contained in Letter No. Misc./A-6/83745-83945 dated:03/05/2018 from The Deputy Registrar (colleges) Panjab University Chandigarh.

- 1. Two additional seats per unit per course subject to maximum limit of four (4) out of the two girl children from the session 2015-16 are created for admission to a given course in Panjab University Teaching Departments, Regional Centers and its affiliated Colleges, provided they are otherwise eligible. The Additional seats will be only for those girl children who are either a single girl child or one amongst the only two girl children with no male child. The additional seat will be available to only one of the two girl children of a couple.
- 2. An affidavit on a stamp paper worth Rs. 20/- duly attested by Class I Magistrate to be obtained from the parents of the girl children declaring therein that the benefit of this scheme is being claimed for only one girl child out of the two girl children and the parents shall not claim the same for the 2nd girl child elsewhere in future. (The Specimen of the affidavit is given on Page No 34)

H. Cancer/AIDS/Thalassemia patients

- 1. One additional seat each for the student suffering from Cancer/AIDS/ Thalassemia has been allowed for admission in each course in Panjab University Teaching Departments, Regional Centres and its affiliated colleges, subject to the condition that the candidate seeking admission under each of these categories is otherwise eligible.
- 2. The claimant candidate will have to submit a certificate as a proof from the National Medical Institute like PGI, AIIMS etc. in support of his/her claims.

NOTE: The benefit of additional seats under the aforesaid categories will not be admissible to the students seeking admission in the courses falling under regulatory agencies such as MCI, DCI, BCI and NCTE.

I. Border Area Students

As per the letter No. Misc./A-6/83946-84246 dated 03.05.2018 from The Deputy Registrar (Colleges) Panjab University Chandigarh, one additional seat over and above the sanctioned seats has been reserved for border area students. The Border Area students shall mean those candidates who have passed their matriculation and 10+2 examination from the Border Area Schools situated within 20 kms from the International Border. A candidate claiming such benefit will have to produce a certificate from the Tehsildar or the Principal/Headmaster/Head of the School certifying that the Schools from where the candidate has passed the matriculation or 10+2 examination, falls within the aforesaid Border Area.

J. Rural Area Students

As per the letter No. Misc./A-6/83946-84246 dated 03.05.2018 from The Deputy Registrar (Colleges) Panjab University, Chandigarh two additional seats for only those candidates will be considered in this category, who have passed their Matriculation and 10+2 Examination from those rural schools that do not fall in the area of Municipal Corporation/Municipal Committee/Small Town/Notified Area. Further, the candidates should have been studying in such school for at least 5 years before passing the last examination. A candidate claiming such benefit will have to produce a certificate from the D.E.O./ Principal of the concerned institute of the area certifying that the school from where the candidate has passed the Matriculation and 10+2 examinations, falls within the aforesaid Rural Area.

K.Weightage for excellence in Youth Festival

- 1. As per letter no PU/DYW/1010-1200 Dated 27.05.2016, approved by syndicate, in all the teaching courses (except the courses governed by AICTE/NCTE/BCI/ MCI/DCI etc.) being run in Panjab University Campus including Constituent Colleges/ Regional Centres / Affiliated Colleges, one additional seat per unit will be reserved for those candidates who have excelled and outperformed in the Youth Festivals.
- 2. The candidates availing the aforesaid weightage must fulfill the eligibility condition for admission to the particular course. For those courses to

which admission is to be done on the basis of entrance test, the candidate must have passed the entrance test. The selection of such candidates for admission to various courses at PU Campus/Regional Centres / Constituent Colleges/ Affiliated Colleges will be made by the respective admission committees.

- 3. For recommending admission on the basis of youth festival participation, admission criterion will be fixed on the basis of merit as mentioned below and upon the verification of the original certificates of those candidates, who:
- a. have presented an item in an international cultural festival approved by Punjab Govt./Govt. of India/Panjab University.
- b. have got distinction in All India National Inter University Youth Festival organized by AIU/Govt. of India.
- c. have got distinction in North Zone Inter University Youth Festival organized by AIU.
- d. have secured First/Second/Third position in Inter University Youth Festival organized by Govt. of Punjab / any State or Central University.
- e. have secured First/Second/Third position in Panjab University Inter Zonal Festival.
- f. have secured First/Second/Third position in Panjab University Zonal Festival.
- g. have secured First/Second/Third position in state level competition of State School Education Board of Punjab/Haryana/HP/or CBSE/ICSE or any other recognized board.
- h. Category A is considered as higher category followed by B, C onwards.

- i. Preference will be given to the candidate/s who have represented Panjab University, Chandigarh in A, B, C or D category.
- j. In case of two or more candidate having equal position at equal level:
- (i) Position secured in an individual item shall be rated higher than position secured as a team member.
- (ii) The eligibility of the candidate for participation in University Youth Festivals, in future, may also be considered.
- (iii) Academic record will be considered in case of tie between two or more candidates.
- 4. In case of any ambiguity, the related certificates shall be verified from the Department of Youth Welfare through the concerned Chairperson/Principal/Head etc.
- 5. The candidate/s admitted on the basis of Youth Festival additional quota seats shall have to give an assurance to the university authorities that during the duration of the course the candidate will participate in the activities associated with his/her item and will not create any kind of indiscipline. The admission committee will assess the participation of the candidate and in case the candidate does not fulfill the requirements, his admission may be cancelled. However, exemption may be given because of specialreasons like sickness or any other unavoidable reason.

L. Weightage for Participation in Cultural Activities

As per letter no. 49411-49601 dated 25-06-2014 from the Deputy Registrar Panjab University Chandigarh, the Syndicate at its meeting held on 26-4-2014 vide paragraph 41 has approved the criteria to give weightage to Cultural Activities for admission to various University courses.

1. NATIONAL CADET CORPS (NCC)

As per decision of the Syndicate Para (13) meeting dated 22.11.2014 and Syndicate Para (36) dated 25-01-2015, regarding accreditation "A, B & C" certificate & weightage 1%, 2% & 3% for NSS volunteers.

- I. A Certificate : 1% of obtained Marks
- ii. B Certificate : 2% of obtained Marks
- iii. C Certificate : 3% of obtained Marks

4. YOUTH WELFARE ACTIVITIES

- Participation in Advanced Youth Leadership Training Camp
- Participation in Youth Leadership Training Camp
- Participation in Advanced Mountaineering
- Participation in Hiking / Trekking
- Participation in Mountaineering
- 1% marks per camp per year (minimum 7 days camp) up to maximum of 3% marks (maximum of 3 camps)

Any other weightage approved by the D.U.I/Vice-Chancellor.

A candidate can claim weight age in one or more categories given above. However, the total weight age allowed shall not exceed 9% of the normalized marks obtained in the qualifying examination. These weight ages shall not be used for determining eligibility for admission as prescribed by the University under its regulations.

Note:

- 1. The student/s belonging to the above categories will also be considered in the general category according to his/her merit. If admitted on the basis of his/her merit in the general category, he/she will not be counted towards the seats reserved for the categories concerned.
- 2. Rules of Reservation policy existing at the time of admission will be applicable.

M. Reserved Categories of Sports

This will be as per rules and regulations of Sports Dept. of the Chandigarh Administration vide Home Secretary letter no. 8493, dated 5-5-2003. Implementation of the policy will be as under:

- 1. 2% of the total number of seats in each course shall be filled up by sportsmen/sportswomen. These 2% seats shall be reserved in both Engineering/Non-Engineering courses in the institutions on the basis of total intake of each branch. Fraction of 0.5 or above shall be rounded off to the next higher number. This category shall not be divided into UT pool/General pool. The inter merit of the candidates seeking admission in any course in the Reserved Category of sports shall be determined only on the basis of their merit in sports as per grading criteria mentioned. In case any of the seats in the sports category in any branch remains vacant, the same shall be thrown open to the candidates of General Category. This policy is for the players of Chandigarh only.
- 2. Benefit of reservation under this category shall be available only to the following category of students:
- i. Those who pass their qualifying examination from Schools/Colleges, recognized by the Chandigarh Administration in the Union Territory of Chandigarh as regular students and have applied for Gradation Certificate will be given admission subject to the condition that such students must represent Chandigarh State/Schools etc. in the National / other recognized tournaments.

- ii. Where the Chandigarh Administration has adopted the notification of other States/U.Ts. on reciprocal basis, to give benefit of reservation to admission in sports category in Chandigarh, they will be graded as per the existing policy of the Chandigarh Administration.
- iii. Countersigning of the Gradation Certificates shall only be admissible on reciprocal basis provided that countersigned certificates will be graded as per the policy of the Chandigarh Administration.
- 3. Students seeking admission under this category shall be considered only:
- i. If his/her age falls within the age group which is eligible for participation in Inter-College/Inter-University tournaments.
- ii. If his/her achievement in sports relates to his/her activity in any of the three years preceding the year of admission. (For example, for admission in the year 2011-12, the Achievements shall not be prior to April, 2008).
- iii. Gradation Certificate will not be meant for employment purposes.
- 4. The Director Sports, Chandigarh Administration, or his nominee, not below the rank of the Joint Director, Sports will issue the certificate, and also have the authority to cancel any certificate at any time if it is found to have been issued on false/incorrect/ concealed information or record.

The merit of certificates shall be graded as A, B, C, D in the descending order. Details of these grades are available with the admission committees of all the colleges.

ADMISSION AFTER RE-EVALUATION

Admission of students whose results are revised as a consequence of re-evaluation or otherwise late declaration of result, can be made only if :

- (I) Seats are available;
- (ii) Candidate is higher in merit than the candidate in waiting list.
- (iii) The request is made before the last date for late admission with the prior approval of the Vice-Chancellor as already laid down.

The following Rule in the P.U. Cal. Vol. III, 2016 at page 489 will be followed in case of re-evaluation cases:

If as a result of re-evaluation, a candidate passes at the Exam., he/she shall be eligible to seek admission to the next higher class within ten working days of the communication of re-evaluation result to him/her. His/her attendance shall be counted from the date of his/her admission. However, no candidate would be granted admission on the basis of revaluation result after 31st December of the academic session. In the case of admission to a course having Semester Exam, the date will be October 15. (Panjab University Handbook of Information, 2021)

CERTIFICATE CONCERNING GAP YEARS

Candidates whose career reflects a gap of years between passing of the last examination and the admission being sought now by them, are required to furnish, at the time of application, an affidavit to the effect, attested by the Magistrate Ist Class/Notary/ that they were not involved in any Offence/Unlawful activities during the gap years. Admission Committee shall satisfy themselves that, during this gap period, the candidates were engaged either in service or in studies. The specimen of the affidavit is given on Page No 33.

BACHELORS DEGREE PROGRAMME

B.A. (GENERAL)

The B.A. (General) programme is a three year degree course under the 10+2+3 system of education divided into six semesters.

A person who has passed the +2 examination under 10+2+3 system of education of a recognised University/ Board/Council or any other examination recognised by the P.U. as equivalent, with pass in English as one of the subjects shall be eligible to join the First Year class of B.A. degree course. However, a person who has not qualified English as one of the subjects at the +2 examination, shall be eligible to join B.A.I Year class provisionally subject to his/her qualifying the deficient subject of English from the parent Board/Body/Council/ University in two consecutive chances subsequent to his admission, failing which his/her admission to B.A.I year class and the result for the examination shall automatically stand cancelled.

ADMISSION SHALL BE MADE ON THE BASIS OF MERIT DEPENDING ON THE NUMBER OF SEATS AVAILABLE.

The details of the subjects to be studied in B.A. (General) First Semester Examination are as under.

- a) A student can opt for only one language out of English. Hindi and Punjabi as Elective Subject.
- b) Only one subject can be opted for out of Sanskrit, Physical Education, Psychology and Geography.
- c) Only one subject out of History and Mathematics.
- d) A student is not allowed any change of subject(s) in BA II and III. It is mandatory to study the same subjects which are chosen in BAI. It is therefore suggested that the combination opted at the time of admission be considered carefully.
- Phy. Edu. can be taken only by those student who have participated in the Inter School/ national e) tournaments. A Student opting for Phy. Edu. is required to clear Physical Efficiency Test.
- Five students offering Sanskrit will be given special scholarship on the recommendation of the Head of the Sanskrit f) Department.
- As there are limited seats in some subjects, students can be asked to offer other subjects by the Admission committee if the g) need arises.
- h) A student would offer Mathematics only if he/she has passed in that subject in the qualifying exam. OR qualifies the subject as a deficient/additional subject from the concerned Board/Council in the supplementary examination subsequent to the admission.
- Change of subject(s) will be allowed after admission in 1st year only if seats in particular subjects(s) are available, and i) strictly according to the University rules. No change of subject would be allowed after one month from the commencement of the session or one month from the date of joining, whichever is later.
- College reserves the right to scrap a particular subject combination if the number of students is less than 10 in that j) combination.

ADMISSION WILL BE OFFERED STRICTLY ON MERIT

Failed candidates need not apply for admission to BA-I.

B.A. PART II & III

Every student is required to study the same subjects in BA-II & III classes as he or she had studied in BA-I (Semester I & II) examinations. Change of subjects is not allowed. The students have the option of taking up Honours in an elective subject they had studied in B.A. I when they take admission to B.A. II.

B.A. II.

No 'Failed' candidate shall be admitted in any of the courses. (The students whose admission forms were duly sent by the Department/College to the Controller of Examinations for appearing in the examination, but did not appear, or dropped the paper, will also be considered 'failed' students under University Rules).

B.A. HONOURS

The college offers Honours in the following subjects: English, Hindi, Punjabi, Economics, Political Science, Sociology, Public Administration, Geography, History and Psychology.

A student may offer Honours in Second Year in anyone of the elective subjects mentioned above. to be studied by him/her in all the three years of the Degree course.

Provided that he/she has obtained at least 50% marks in the subject of honours in the First Year of the BA. (General) Course.

B.Com-I

The B. Com. (General and Honours) is a three years degree course under the 10+2+3 system of education divided into six semesters. Admission to the First Semester of B.Com. (General) Degree course shall be open to a person who has passed one of the following examinations conducted by a recognised Board/Council/University.

- a) 10+2 examinations or B. Com. Part I (Old Scheme) of Panjab University with three of the following subjects securing at least 50% marks in aggregate.
- b) 10+2 examination or BA I (Old Scheme) of the Panjab University with at least two of the subjects mentioned in (a) securing at least 45% marks in aggregate.
- c) 10+2 examination or B.A. I/ B.Sc I/ Pre-Engineering/Pre-Medical examination of the Panjab University under the (Old Scheme) not covered in (b) securing at least 50% marks.
- d) Any other examination recognised by the university as equivalent to (a), (b) or (c) as given above with requisite percentage of marks given under each clause.

Provided that a candidate seeking admission to the first year of B. Com should have passed in the subject of English at the +2 examination and in cases where passing in English is not necessary according to the regulations of certain Boards/ Bodies/ Councils/ Universities in India, the admission of the candidate shall be provisional and will be confirmed only after he/she has cleared the subject of English as a deficient subject from the parent Board/ Body / Council / University in two consecutive chances subsequent to his/ her admission.

B.Com (HONS.)

A student who has secured at least 50% marks in B.Com I shall be eligible to offer Honours in B.Com II. The Honours examination shall consist of two papers out of which paper I shall be taken along with the lInd year exam and paper II with the final year exam.

The college offers two options

- I) Business Finance & Accounting
- ii) Banking

BCA-I (BACHELOR OF COMPUTER APPLICATION)

A person who has passed the following examinations shall be eligible to join the first year class of BCA Course:

- a) (I) 10+2 examination in any discipline with at least 50% marks
- (ii) Having passed Matriculation examination with Mathematics as one of the subjects.
- b) Any other examination recognised by the Syndicate as equivalent to (a) above.

Note: 5% Weightage will be given for each of the subjects of Mathematics & Computer Science/Information Technology to the candidate who studied at 10+2 level at the time of admission in B.C.A. 1st Semester.

BBA-I (BACHELOR OF BUSINESS ADMINISTRATION)

The admission to the 1st Semester of the course shall be open to a person who has passed:

- $1.\ 10+2\ examination\ from\ a\ recognized\ Board/University\ with\ at\ least\ 50\%\ marks.$
- $2.\,$ Any other examination with 50% marks recognised as equivalent to 1 above.

Note: 5% Weightage will be given to the students who have passed qualifying examination with atleast 3 commerce subject e.g. Accounting, Economics, Business Management, Banking & Trade, Commercial Geography, Office Management, Auditing, Computer Applications, Information Technology.

B.SC.-I (GENERAL)

A person who has passed with at least 40 per cent marks in the aggregate the +2 examination under 10+2+3 system of education of a recognised University/Board/Council or any other examination recognised by the P.U.as equivalent, with pass in English as one of the subjects shall be eligible to join the First Semester class of B.Sc.I degree course. However, a person who has not qualified English as one of the subjects at the +2 examination, shall be eligible to join B.Sc. Ist Year class provisionally subject to his/her qualifying the deficient subject of English from the parent Board/Body/ Council/University in two consecutive chances subsequent to his admission, failing which his/her admission to B.Sc.I year class and the result for the examination shall automatically stand cancelled.

Provided that a student would offer any science subject, including Mathematics, only if he/she has passed that subject in the qualifying exam OR qualifies the subject as a deficient / additional subject from the concerned Board / Council in the supplementary examination, subsequent to the admission.

The details of the subjects to be studied in B.Sc (General) First Year Examination are as under:

Compulsory Subjects

a) Punjabi / History & Culture of Punjab.

- b) Three elective subjects.
- c) Environment Education.

Elective Subjects

A student can opt for any of the following combinations of three elective Subjects.

- 1. B.Sc. (Medical) Botany, Zoology and Chemistry.
- 2. *B.Sc. (Biotechnology elective) Biotechnology, Botany and Chemistry.

or

- *B.Sc. (Biotechnology elective) Biotechnology, Zoology and Chemistry.
 *Students opting for combination No. 2 & 3 in B.Sc-I (General) are required to mention B.Sc. Elective (Biotech.) as the course on top of 1st page of the admission form.
- 4. B.Sc. (Non-Medical) Physics, Maths and Chemistry.
- 5. B.Sc. (Computer Science) Physics, Maths and Computer Science.

Note:

Prerequisite subjects at +2 level:

- $I) \quad Combinations 1 to 5 can be opted by students if they have studied Physics, Chemistry and Biology at +2 level.$
- ii) Combinations 6 & 7 can be opted by students who have studied Physics, Chemistry and Maths at +2 level.

B.Sc. Hons (Biotechnology) Duration

The duration of the courses for the degrees B.Sc. in Biotechnology shall be three years.



Eligibility

A candidate must have passed Senior Secondary Part-II (12th Class) examination with a minimum of 50% marks in medical or non-medical science group from CBSE or any other board recognized by the Panjab University. OR Any other examination recognised as equivalent to above by the Panjab University.

Eligibility Criteria for Bachelor of Science (General) 3rd and 5th semester

Any candidate who is admitted to the 1st/3rd/5th semester will be allowed to be promoted to 2nd/4th/6th semester respectively. However, for promotion from 2nd to 3rd or from 4th to 5th semester the candidate will have to clear 50% of the total papers till that semester. It is further clarified that for calculating 50%, fractions like 2.5, 3.5 or 4.5 will be considered 3, 4 or 5 respectively.

Eligibility Criteria for Bachelor of Science in Biotechnology (Honours) 3rd and 5th semester

Any candidate who is admitted to the 1st/3rd/5th semester will be allowed to be promoted to 2nd/4th/6th semester respectively. However, for promotion from 2nd to 3rd or from 4th to 5th semester the candidate will have to clear 50% of the total papers till that semester. It is further clarified that for calculating 50%, fractions like 2.5, 3.5 or 4.5 will be considered 3, 4 or 5 respectively.

B.VOC DEGREE IN FOOD SCIENCE AND TECHNOLOGY

B. Voc Degree in Food Science and Technology is affiliated with Panjab University, Chandigarh.

The B.Voc degree programme is a full time degree course.

Candidate will be eligible to receive Diploma after first 2 semesters and Advance Diploma after 4 semesters and for Degree after six semesters according to guidelines of UGC.

No candidate will be allowed to join any other course or service simultaneously.

There shall be an examination at the end of each semester.

B.Voc. Degree in Medical Lab Technology

(Under UGC B.Voc program)

B.Voc. Degree in Medical Lab Technology is affiliated with Panjab University, Chandigarh.

The B.Voc degree programme is a full time degree course.

Candidate will be eligible to receive Diploma after first 2 semesters and Advance Diploma after 4 semesters and for Degree after six semesters according to guidelines of UGC.

No candidate will be allowed to join any other course or service simultaneously.

There shall be an examination at the end of each semester.

General educational Credits for Diploma: 24 and Skill Component Credits: 36

General educational Credits for Advance Diploma: 48 and Skill Component Credits: 72

General educational Credits for Degree 72: and Skill Component Credits: 108

The Skill component of the course are assessed and certified by the respective Sector Skill Councils.

Candidate to the admission of bachelor of vocational- Degree in Medical Lab Technology must have passed standard 10+2 Science (Medical/Non-Medical).

Postgraduate Degree Programmes

Master of Commerce

M.Com (Business Economics)

This is a two year course divided into four semesters. The admission to this course will be on the basis of merit calculated as per rules. ITEM 8 Regulations for M.Com. (Business Economics) (effective from the session 2015-16).

The minimum qualification for admission to the first semester of the course shall be- (i) A Bachelor's/Post-graduate degree in any discipline of the University or a degree of any other University which has been recognized by the Syndicate as equivalent thereto with not less than 50% marks in the aggregate. Provided that in case of candidates having Bachelor's degree of the University through Modern Indian Languages [Hindi/Urdu/Punjabi (Gurmukhi Script)] and/or in a Classical Language (Sanskrit/Persian/Arabic) or degree of any other University obtained in the same manner recognized by the Syndicate, 50% marks in the aggregate shall be calculated by taking into account full percentage of marks in all the papers in language excluding the additional optional paper, English and the elective subject taken together.

OR

 (ii) Pass in the final examination conducted by the (a) Institute of Chartered Accountants of India or England (b) Institute of Cost and Works Accountants of India or England and (c) Institute of Company Secretaries of India.

OR

(iii) AMIE examination with 50% marks or more after having passed the diploma examination with 60% marks or above and have at least 5 years research/teaching or professional experience.

OR

(iv) Any other qualification as recognized by the Syndicate for this purpose.

Note : Any changes in the PU ruling

M.COM

The duration of the course shall be two academic years. Each year shall be divided into two semesters.

There are four semesters in M.Com. Each Semester lasting six months consists of five papers. Each paper is of 100 marks (Written Test - 80 marks and Internal Assessment - 20 marks). In addition to this, Summer Training Report is to be submitted by the students after 2nd Semester. There is comprehensive Viva Voce based on all the four semesters at the end of the 4th Semester.

Admission to M.Com is based on merit. The admission will be made strictly according to Panjab University rules.

Eligibility

The minimum qualification for admission to the first semester of the course shall be:

a) A Bachelor's degree in Commerce with not less than 45% marks in the aggregate.

OR

b) B.Com. (Hons.) Degree with not less than 45% marks in the aggregate.

ÓR

c) A graduate with Honours in Economics OR, Mathematics OR Statistics OR Commerce with not less than 45% marks in the aggregate.

OR

- d) A graduate with 50% marks in aggregate having offered either Economics, Mathematics, Statistics OR Commerce as a subject in the examination Provided that in case of candidates having Bachelor's degree of the University through Modern Indian Languages (Hindi/I Urdu/I Punjabi (Gurmukhi Script) and/ or in a Classical Language (Sanskrit / Persian / Arabic) or a degree of any other University obtained in the same manner recognised by the Syndicate 50% marks in the aggregate shall be calculated by taking into account full percentage of marks in all the papers in Language excluding the additional optional paper, English and the elective subject taken together.
- OR
- e) An associate of the (i) Institute of Chartered Accountants of India or England or (ii) Institute of Cost and Works Accounts of India or England.

OR

f) A pass in the final examination conducted by the institute of Company Secretaries of India OR any other qualification recognized by the Syndicate for this purpose.

Provided that a candidate who seeks admission on the basis of qualifications mentioned in (c) (d) and (f) above shall be required to qualify within one year from the date of admission (either with Semester I examination or with semester II

examination) in a special examination in two papers on (i) Commercial and Taxation Laws, and (ii) Accounting and Auditing in accordance with the Syllabus as may be prescribed, by the Senate. Further that the maximum marks shall be 100 in each paper and the pass marks shall be 35% as in B.Com. examination. There shall be no internal assessment in these papers and marks in these papers will not be counted for the semester examination.

MASTER OF ARTS (M.A.) IN ENGLISH, ECONOMICS, PSYCHOLOGY, PUBLIC ADMINISTRATION & SOCIOLOGY

Admission will be made strictly in order of merit. for admission to M.A. (1st semester). In case the College/ Departments decides to hold Entrance Tests at their level, the following procedure will be followed besides the rules/regulations of Panjab University governing eligibility in a particular subject.

(i) Academic Weightage 60%

a. 10th Class 10%

b. 10+2 Class 10%

- c. B.A./B.Sc./B.Com. 40%
- (ii) Written and Oral Test / Aptitude Test 40%
 a. Written Test of one hour duration 25%
 - b. Aptitude Test (wherever applicable) 15%
- (iii) Weightage for Panjab University 5%
- (iv) Weightage for Honours 15%

The duration of the course of instruction for the Master of Arts examination shall be two years and the examination shall be held in four semesters. First and Third semesters shall be from July to December and Second and Fourth semesters shall be from January to May, respectively, or as decided by the Vice-Chancellor. The examination shall be conducted at the end of each semester only in those courses which have been offered in that semester.



A person who has passed one of the following examinations from the Panjab University or an examination recognised by the Syndicate as equivalent thereto, shall be eligible to join the M.A. degree course :—

- (i) A Bachelor's degree obtaining at least 45 per cent marks in the subject of Postgraduate course or 50 per cent marks in the aggregate.
- (ii) B.A. with Honours in the subject of the Postgraduate course or B.Sc. Hons. School course.
- (iii) Master's degree examination in any other subject. Provided that-
- (a) For the Public Administration course, a person who has passed B.A. with 45 per cent marks in any one of the subjects Political Science or Economics or Sociology or Psychology or History.
- (b) For Post Graduation in Psychology a Bachelor's degree obtaining at least 45% marks in the subject and 50% marks in the aggregate are required.

For the Psychology course, a person who has passed the B.A. (2 year Course) examination with Philosophy as one of his subjects, obtaining 45 per cent marks in both the papers of Philosophy or in the Psychology paper alone or a person who has passed B.A. (3 year Course) examination obtaining 45 per cent marks in the subject of Philosophy, shall also be eligible.

(c) For the Economics course, a person who has passed the B.Com. examination with 45 percent marks in the subject of Economics shall also be eligible.

Explanatory Note :

67 marks out of 150 shall be accepted as 45% marks in the subject of Postgraduate course.

A candidate shall be deemed to have passed the examination if he obtains 35% marks in each paper. Each candidate shall be required to obtain pass marks in each course of theory and practical separately for each semester.

- The following are not eligible for admission to M.A. courses:
- (a) If a student fails to pass M.A. Part/ Semester-I or fails to appear in the examination even though he/ she had requisite attendance, he/she is not allowed to seek re-admission for M.A. Part/Semester-I in the same subject.
- (b) If a student fails to meet the prescribed attendance requirement, and is, therefore, debarred from sitting in the examination, or does not on his/her own volition seek permission to sit in the examination he/she should be deemed to have failed in the examination. Such a student is not allowed to seek re-admission in the same Department;
- (c) If a student fails to earn promotion to the M.A. Part-II or the next semester of M.A. for any of the reasons specified in Paras (a) and (b) above for two successive years in the same or two different Departments, he/she is debarred from seeking admission in any Departments.

(d) In order to ensure the implementation of the above conditions, the columns given in the Admission Form, seeking information from the applicant on the course(s) attended by him/her in the preceding three years must be filled by him/her.

If he/she leaves these columns blank, the admission form will be rendered invalid and if he/she makes mis-statement or conceals relevant facts, his/her admission will be cancelled even if made.

MASTER OF SCIENCE (M.Sc.)

The College offers the Master of Science programme in the following subjects: Biotechnology^{*}, Chemistry^{*}, Zoology^{*}, Physics^{*} and Mathematics.

*Admission to these courses will be on the basis of entrance test PU-CET (P.G.) conducted by the Panjab University. Only the rank holders in these entrance test will be considered for admission. 50% weightage will be given to the score in entrance test & 50% to the score in the qualifying examination.

Eligibility for M. Sc. Biotechnology

Bachelor's degree in Physical, Biological, Pharmaceutical, Agricultural, Veterinary, Fishery Sciences, Engineering, Technology Medicine (MBBS) with at least 55% marks.

Eligibility for M. Sc. Chemistry

- a) B.Sc. Honours School examination of the Panjab University in Chemistry.
- b) B.Sc. examination of the Panjab University securing at least 50% marks in the subject of Chemistry and 50% marks with Chemistry &Mathematics along with anyone of the following subjects: Biochemistry, Botany, Geology, Physics, Statistics, and Zoology. Provided that a student who had not taken up Mathematics as one of the subjects in B.Sc examination may be admitted to M.Sc. (2 Year Course) in Chemistry on the condition that he passes an additional paper in Mathematics in the first semester examination securing at least 40% marks.
- c) Awarded B.Sc. Pass degree under the old B.Sc. Honours School regulations by the Syndicate on the recommendation of the Board of Control;
- d) B.Sc. Honours School examination in the subject of the M.Sc. from any other University recognized by the Syndicate as equivalent to (a);
- e) B.Sc. examination of any other University recognized by the Syndicate securing at least 50% marks in aggregate with Chemistry & Mathematics along with anyone of the following subjects: Biochemistry, Botany, Geology, Physics, Statistics, and Zoology.

Eligibility for M. Sc. Mathematics

- a) B.Sc. Honours in Mathematics of the Panjab University.
- b) B.A./ B.Sc. with Honours in Mathematics of the Panjab University or from any other University recognized by the Syndicate as equivalent there to;
- c) BA/B.Sc. (Pass) with Mathematics having either at least 50 %marks in the aggregate or at least 45% in Mathematics of the Panjab University or from any other University recognized by the Syndicate as equivalent thereto:

Eligibility for M. Sc. Zoology

B.Sc. (Pass) with Zoology having at least 50% marks in aggregate, of the Panjab University or from any other University recognized by the Syndicate as equivalent thereto;

Eligibility for M. Sc. Physics

- a) B.Sc. Honours School in Physics from the Panjab University.
- b) B.Sc. (Pass) with Physics having at least 50% marks in aggregate, from the Panjab University or from any other University recognized by the Syndicate as equivalent thereto.

Postgraduate Diploma Courses (Evening Classes)

The College offers the following Postgraduate Diplomas in the evening:\

- 1. Postgraduate Diploma in Computer Application
- 2. Postgraduate Diploma in Marketing Management
- 3. Postgraduate Diploma in Mass Communication

The duration of each course is one year. The classes of these courses would be held in the evening.

How to Apply

On the spot admission would be granted to these courses on first come, first serve basis. Candidates should appear for the interview with all documents, and completed application forms as per admission schedule.

Post Graduate Diploma in Marketing Management (PGDMM)

Eligibility

The minimum qualification for admission to First Semester of the above two courses shall be:

a) A Bachelor's/ Post-graduate degree in any discipline of the University or a degree of any University which has been recognised by the Syndicate as equivalent thereto; with not less than 45% marks in the aggregate:

Provided that in case of candidates having Bachelor's degree of the University through modern Indian Languages (Hindi/ Urdu / Punjabi (Gurmukhi Script) and / or in a Classical Language Sanskrit / Persian / Arabic) or a degree of any other University obtained in the same manner, recognised by the Syndicate, 45% marks in the aggregate shall be calculated by taking into account full percentage of marks in all the papers in Language excluding the additional optional paper, English and the elective subject taken together.

OR.

a) A pass in the final examination conducted by (a) Institute of Chartered Accountants of India or Institute of Chartered Accountants of England and Wales, or (b) Institute of Cost and Works Accountants of India or Institute of Cost & Management Accountants incorporated by Royal Charter, London, or (c) Institute or Company Secretaries of India.

OR

c) AMIE examination with at least 50% marks.

Postgraduate Diploma in Computer Applications (PGDCA) Eligibility

Graduate (B.A./B.Sc./B.Com./B.C.A. under 10+2+3 system of examination) i.

OR

ii. B.E./B.Tech.

OR

iii. Any other examination recognized by the Syndicate as equivalent to (i) or (ii) above with atleast 50% marks in any discipline.

Post Graduate Diploma In Mass Communication (PGDMC)

Eligibility

The admission to the course shall be open to any person who has passed the Bachelor's degree examination in any faculty from Panjab University or any other University recognised as equivalent thereto.

GUIDELINES FOR REGULAR STUDENTS

Eligibility Rules for the University Semester Examination

The students can appear in university examination only if they fulfill the following conditions:

- (1) A student has to attend 75% of the total lectures delivered to the class in each subject including practical classes during the each semester.
- (2) A student of B.A./B.Sc./B.Com., etc. must obtain at least 25% marks in aggregate of all subjects in terminal examinations.

Note

A special test may be held at the discretion of the Principal, and the student shall qualify in the special test only if he/she obtains at least 30% marks in the aggregate of all the three elective subjects. If a student fails to obtain the required percentage of marks, his/her candidature from the University exam will be withdrawn.

Environment Education & Road Safety Examination

This is a compulsory qualifying paper, which the students have to study in the B.A. / B.Sc. / B.Com. / BBA / BCA 1st year. The students are required to qualify this paper either in the 1st year, 2nd year or 3rd year of the course. The examination is conducted by the University.

Note

Admission criteria and course contents are subject to revision by the Panjab University.

Rules for Withdrawal

- 1. A student who wishes to leave the college must apply in writing to the Principal; the application must be countersigned by his parent or a responsible guardian. No student will be permitted to leave the college until he/ she has cleared all the college dues.
- 2. A student has to pay the college fees and all other dues until his/her name is formally withdrawn.

Refund of Fee

Refund of fee will be done as per DHE/PU/UGC Guideline.

System of Continuous Assessment for Postgraduate Classes

The under mentioned mode of Testing and Evaluation is followed.

- 1) Terminal Exam-80%.
- 2) Continuous Assessment-20%
 - Continuous Assessment may include written assignments, snap tests, participation in discussion in the class, term papers, attendance, etc.

Security

Security deposited with the college at the time of admission will be refunded when a student leaves the college.

Cancellation of Seats / Admissions

Admission of all such students who fail to attend atleast 33% of the total lectures delivered and practicals held in all the papers during the first 10 days from the start of teaching work in the course concerned, shall be cancelled by the College after following the procedure given below:

- 1. By the 12th day after the start of classes for a particular course, that names of those students who fail to attend at least 33% of the total lectures/ practicals shall be put up on the college Notice Board. Within 4 days of the date of such notice, a student who is short of attendance may give in writing the reasons for his/her absence from the classes.
- 2. If a student does not submit an application in writing within the prescribed time as stated above, or the reasons adduced by the student in his/her application are not found to be sufficient and justified in the opinion of the authorities, his/her admission shall be cancelled by the college.
- 3. All the seats thus falling vacant shall be filled from the waiting list or through subsequent counseling.
- 4. When the admission of the student is cancelled as stated above, the college shall display on the Notice Board the list of the person(s) next in the waiting list and make admissions accordingly.

Note: It is obligatory on the part of students to keep in touch with the college for the possibility of the seats to fall vacant.

In case a student absents himself continuously for 5 days, his/her name will be struck off the College rolls automatically.

Verification of Certificates All certificates submitted by the candidates at the time of application in support of their claims shall be checked against the originals at the time of interview.

For the marks obtained, the original certificates shall be ones issued by the University/Board concerned only, and NOT by any Principal of a School/College.

In case a candidate happens to have surrendered the original certificate to an institution/ office, as for re-evaluation etc., a copy of the certificate duly attested by the candidate himself / herself, or a Class-1 Officer of the University or a Gazetted Officer may be considered, after a satisfactory explanation from the candidate. Admissions based on such certificates shall be treated as provisional.

A certificate, submitted by the candidate in support of a claim made by him/her, should be in the format prescribed by the issuing authority. No deviation from this shall be made.

Verification of SC/ST Certificates

The admission of the SC/ST candidates producing the requisite certificates of being SC/ST for admission to various courses at this college/university is made provisional subject to verification of the certificates from the issuing authority.

Discipline

The college lays special emphasis on the maintenance of discipline and proper decorum in and outside the classrooms.

Students are expected to show proper respect to their teachers, be polite to one another and show courtesy to the employees of the college.

In order to create the right academic atmosphere in the college, the students should maintain silence while moving on the campus and sitting in the Library. Movement from one room to another should be orderly.

In vacant periods the students must move to the Library.

Absence from the composition or tutorial period entails a fine and disciplinary action.

Smoking and ragging are strictly prohibited on the College Campus and Hostel Premises. Crossing through lawns is to be avoided.

No cycling is permitted on the College Campus. All cycles/scooters/ motorcycle/cars should be parked in the space provided for them. The students are not allowed to park cars either inside or outside the College.

Quarrels and disputes with fellow students should be avoided. A complaint in writing should at once be made to the Principal whenever there is a dispute. The students should not take the law into their own hands.

Students who violate the above rules shall be liable to punishment which may be in the form of a heavy fine, withdrawal of concessions and stipends and in extreme cases, expulsion from the college.

Use of mobile phones in teaching area by the students is strictly prohibited. A fine of Rs. 1000/- would be levied on any student caught violating this rule.

Dress Code

Articles of Clothing should be as per the guidelines i.e. inappropriate articles of clothing are strictly prohibited in the college campus.

Prizes

Academic

On the Basis of University Examination

Two prizes shall be awarded in each elective subject. If the total number of students in a subject is less than ten, there will be only one prize.

The qualifying marks will be at least 60% for Science subject.

Other than Academic

Prizes, Roll of Honour are also awarded for outstanding achievements in sports, community service and extra curricular activities

Hostel Admission

For admission to the College Hostels, a separate Prospectus is available on the college website. Until accompanied by his/her parent or a responsible guardian, no student is admitted to the Hostel. Admission to the College Hostels can be refused without assigning any reason.

Hostels for Girls

Hostel accommodation will be provided strictly on merit for 400 girls in the hostels attached to the college campus. All essential facilities are available to the boarders. AC rooms also available. Maintaining security, academic atmosphere and providing hygienic food to the boarders will receive utmost attention of authorities.

Hostel for Boys

Hostel accommodation will be provided strictly on merit for about 250 students. Ragging is strictly prohibited in or outside the hostels. Anyone found guilty will be dealt with strictly and may even be expelled from the college.

Counselling

College also provides the services of a professional counsellor for the students who fall prey to the stress and strain of academic burden or face other personal problems.

Aid to Students

The college does its best to look after the needy and deserving students and arranges help for them in the form of books, grants, scholarships and lump sum grant from the Students Aid Fund. Various organizations and individuals have also instituted some scholarships. The meritorious students in academics as well as in sports get incentives. For all the scholarships, the students have to apply in writing to the Principal/Scholarships Committee.

All types of State, Central Govt, scholarships are available in the college as follows:

- 1) The Govt, of India Scholarships under:-
- a) National Loan Scholarship Scheme
- b) National Talent Scholarship
- c) Sports Talent Scholarship
- d) Post Matric Scholarships for students belonging to Scheduled Castes.
- e) Grants-in-aid scheme of scholarships to students from Non-Hindi speaking states for Post Matric studies in Hindi.
- f) National Merit Scholarship Scheme
- 2. U.T. Administration Scholarship for SC/ST students only.
- 3. Sports Authority of India Scholarship for outstanding sportsmen.
- 4. Students Aid Fund Scholarship-from the UGC and partly from the college.
- 5. Donor Scholarships.
- 6. The college awards five special scholarships to deserving students of Sanskrit for the promotion of the language.

Half Fee Concession in Tuition Fees

This is open to all students. For availing this concession, the income of the parents of the student from all sources should be up to Rs. 1,00,000/-. per annum. The student has to fill a separate form, available in the college office in case he/she wishes to avail of this concession.

General Rules for Scholarships

- 1. All cases for help are scrutinized by a duly constituted committee
- 2. A lump sum aid is granted to:
- a) pay college dues
- b) meet hostel expenses
- c) purchase books and
- $d) \quad incur \ other \ expenditure \ considered \ necessary \ and \ useful \ for \ the \ Student.$
- 3. Applications are considered as long as the funds last.

All students belonging to Scheduled Tribes/Scheduled Castes/Other Backward Classes will get application forms for Government of India/State Government scholarships from the college office and submit them duly completed within one week from the date of admission. There are two kinds of application forms for Scheduled Caste/Tribe students-one for the fresh candidates and the other for renewal of those who enjoyed scholarships in the previous year. The College will not be responsible if there is any delay in getting the scholarship.

Fee concessions, Stipends and scholarships of all categories are liable to be withdrawn if performance in studies falls or a student remains irregular in attendance or is found guilty of misbehaviour. Deserving students, who take part in Arya Samaj and Arya Yuvak Parishad Activities, attend prayer meetings and other lectures and functions regularly will be shown regard at the time of awarding concessions, stipends and allotment of seats in the Hostel. Students can apply afresh for concessions if they show creditable result in the House Examinations.

College Leave Rules

Leave must be applied for in advance on the prescribed leave form available from the office on payment. In case a student absents himself/herself continuously for five days, his/her name will be struck off the college rolls automatically. The maximum leave allowed to a student during the year is 15 days only. In case of serious illness, the leave application must be submitted as soon as possible along with the medical certificate. Leave up to 3 days will be granted by the tutor and more than 3 days by the Principal.

College Library:

The library of DAV College is well stocked and well equipped to fulfill the knowledge and information needs of the readers. Consistent efforts are always made to upgrade its all round infrastructure. The Library provides conducive atmosphere and

sufficient seating facility to its readers for browsing and relaxed reading. A stimulating environment is provided to encourage readers enhance their academic worth. The building of the library is multi-storeyed, well ventilated and air-conditioned as well. On the ground floor there is circulation section, stack areas, meditation room, property counter, outer reading hall and Lal Chand Research Library. The outer reading hall of the library is kept open late in the evening before and during the examinations. The Open shelf system is provided in the stack areas from where the students can get the books issued. There is a rich collection of books in the streams of humanities, social sciences, sciences, IT, language, literature, commerce and management. On the first floor of the library there is reference section and the textbook section. All kinds of reference material like dictionaries, encyclopedias, yearbooks, directories, maps, gazettes and gazetteers, reference books belonging to specific disciplines are housed in the reference section of the library. In the textbook section one copy each of textbook of every subject is kept in this section. On the top floor of the library there is periodical section, biography section and digital corner. This section houses magazines, multi-faculty journals, newspapers, biographies and autobiographies. 24 computer systems have been installed in the digital corner of the library for our faculty members and the research scholars of our college. CDROMs covering literature and various other subjects are also provided in the Periodical Section of the Library.



Library is fully tech-enabled in operations and services. There are 10 computers which enable us to perform the in-house operations in an efficient, time and cost saving way. It has been using Campus Whiz software for Library automation. In house binding and Xerox service is also provided. It is our whole hearted endeavor to provide right and timely information to the readers from the vast collection and the updated OPAC. College students can also avail the Internet facility through Wi-Fi. Library also provides access to e-resources through the databases like NLIST and J-Gate Social Sciences and Management to our esteemed faculty members and the college students. Library issues Unique Smart ID cum library cards to all the bonafide students and to all the staff members and the faculty of the college. It also provides back sets of Journals and Magazines, University Syllabi, Old Question papers of University exams.

RUSA has proved to be a boon to the library enabling us to bring in better access, quality and expediency in tech-driven way. Financial assistance has been provided to upgrade the infrastructure of the library. Large number of books has been added to the collection. Data card printer, Information KIOSK has been installed in the library premises. The whole setup of RFID comprising RFID Security Gates, Staff Station, Book Drop Box, RFID KIOSK (Self check-in and Self Check-out), RFID Tags, RFID enabled Id cards, RFID Hand held reader have been incorporated in the library solely with the huge financial assistance from RUSA. This high end set up has made worthy readers more tech savvy in fulfilling their knowledge and informational needs.

To ensure students' active participation in the library, various activities are held from time to time like book exhibitions, signature campaign and training workshops on knowledge based themes. Library is marching ahead in the mission of providing reader friendly ambience and services.

Library Rules

- 1. Books are issued to students as per their entitlement.
- 2. A fine of Re 1/- per day per volume is charged for the books returned after the due date.
- 3. Reference books, text books, rare books and periodicals are not issued except for consultation in the library
- 4. The students are required to possess their identity cards while inside the Library/Reading Rooms. Defaulters will be asked to leave and their cases

will be reported to the Principal.

- 5. Books issued from the Library should be kept carefully and in no case be underlined or disfigured. If a book is already damaged in any form, it should be reported to the issuing clerk or the Librarian. Once the book is issued the student will be held responsible for the damage.
- 6. The loss of a book should be reported to the library before the due date in the absence of which the usual fine will be charged. The borrower will be required to replace it or to pay double its price along with his next college dues if the book is not replaced.



- 7. The students are expected to observe silence in the Reading Room and not to disturb others in any way.
- 8. Special Library service, for extended hours, is provided near examination days.
- 9. Needy and meritorious students are issued books for the whole session.

During the COVID-19 pandemic PHASE the library has set up a "Library Helpdesk" on the Student portal of our college. The email ids of the professional staff of the library are provided on which students are forwarding their queries. Library services as per the requirement of the students are duly been provided by the staff. Apart from this, faculty members, research scholars and students can access e-resources through the databases namely NLIST and JGATE: Social Sciences and Humanities. The library extends its services through its website. From the infrastructure to the services -online and offline both it is an extremely helpful platform for the students. They can also search the question papers of previous years and syllabi as well. Various ICT links have also been provided on the website which are helpful for the students in their academics and career. Keeping in view the special needs of visually challenged students, the library has set up an exclusive corner for them. JAWS software has been procured so that they can seek their knowledge and information needs. Reading material in Braille has also been kept for them.

Lal Chand Research Library:

Another landmark feature of our college is Lal Chand Research Library which has completed 100 years of its existence. The library was established in 1917 in Lahore by the DAV College Management Trust and Society after the name of Rai Bahadur Lal Chand, the first president of the Trust. Thousands of manuscripts were collected from the nooks and corners of various villages around Lahore and other areas. Unfortunately, at the time of the exodus brought on by the Partition, a lot of these valuable manuscripts were lost or burnt. However, there were some very dedicated and fearless individuals who somehow managed to rescue some of this priceless wealth. Those manuscripts that could be saved were kept at a godown in Amritsar and in Vishveshvaranand Vishwa Bandhu Institute of Sanskrit and Indological Studies, Hoshiarpur, under not-so-ideal conditions. In the late nineties these were brought to the D.A.V. College, Chandigarh where a herculean effort is underway to preserve and protect them. The library today has a collection of almost 8,360 rare manuscripts. Apart from the manuscripts, as many as 10,303 rare books are also part of the library's inventory. As many as 6,462 manuscripts are paper based, while 1,898 are written on palm leaves in various Indian and South Indian scripts namely Devanagari, Sharada, Grantha, Gurumukhi, Utkal, Banga, Nandi, Nagari, Kannada, Malyalam, Tamil and Vartala. Apart from Kautilya's Arthshastra, Valmiki's Ramayana, Mahabharata and the Bhagvad Gita, Shankar Bhashyam among many others, the manuscripts also comprise Ashvalayan Sharut Shutra, the first 'Shutra' (ritual manuals) of Rig Veda, and Kartika Ratnam. This astonishing collection spans 45 subjects, including the Vedas, Brahamanas, Dharamshastras, literature, philosophy, art, astronomy, architecture, ethics and linguistics. Detailed records of



drawings and measurements of monuments such as the Taj Mahal, the Qutab Minar and the Golden Temple can also be found here. Some of the rare books stocked here are Nirukta, a standard in linguistics by author Yaska, Charak Samhita, Mahabhasya, Leelawati and Kamasutra. Then there are some very rare ones on Ayurveda. However, in many manuscripts, the year of composition is not mentioned. Most writers did not even give their names to the scriptures they wrote. The library has a

rare book on medicinal plants by Major BD Basu that was published by Panini Office, Allahabad in 1918. These manuscripts are being given a new lease of life in our college and have been preserved for posterity. The paper manuscripts have been laminated and the palm leaf manuscripts have been incised with a metal pen. The blackening of the text on palm leaf manuscripts is being done with the periodic application of lemon grass oil with coal dust. The rich collection of paper manuscripts is being uploaded on the website: www.splrarebooks.comThe staff at the library of D.A.V. College, Chandigarh has worked wonders with this archival treasure. With the aid of latest technology, we have succeeded in protecting and preserving this magnificent heritage. Many scholars from India and abroad have shown keen interest in these manuscripts and books. The sustenance of more than 100 years of this rare treasure of ancient knowledge owes its existence to the efforts of authorities and the team work and dedication of library staff. We work on the principle of preserving the heritage for posterity.

Sports

College students are required to take part in games regularly. Ample provision exists on the college campus for various games and sports. The college participates in tournaments of Cricket, Tennis, Table Tennis, Badminton, KhoKho, Gymnastics, Yoga, Athletics Judo, Boxing, Cross Country, Relay races, Ball Badminton, Rowing, Water Polo, Wrestling, Shooting, Softball, Squash Racquet, Archery, Basketball, Swimming, Netball, Chess, Power lifting, Best Physique, Cycling, Kayaking, Canoeing and Handball.

Sportsmen of outstanding merit are granted handsome concessions. The sportsmen are expected to establish healthy traditions regarding dress, behaviour and attitude.

Sports Facilities

All latest physical education literature and equipment are available with Department of Physical Education of the College. The following facilities are available.

D.A.V. College, Chandigarh has become a pioneer to provide shooting infrastructure to rifle and pistol shooters by setting up an electronic target shooting range in the college. The fully air-conditioned range has been constructed keeping in mind the international standards with all the latest facilities such as SCATT Shooter Training System, Biofeedback and Neuro feedback

System along with various other imported computerized apparatuses for psychological training of the shooters.

- c) Outstanding students are awarded College Colours/ Roll of Honour.
- d) A running trophy and a cash prize of Rs. 2100/- is awarded to the best sportsman of the year. This scholarship has been donated by Principal S. Marriya in memory of his reverend mother.
- e) Sports Authority of India, Scholarships.
- f) Special quota of seats for admission is reserved for sportsmen as per P.U. Rules.

National Cadet Corps

The college is known for the emphasis it lays on NCC training. All the three wings exist in the college. Students can join one of these wings depending on their aptitude and physical fitness. They are also prepared for

Regular commission in the Army, Navy and Air Force.

As per NCC rules, a cadet is required to attend the annual training camp of the unit each year and undergo service training for a period of 65 hours or 96 periods or 32 parades during the academic session.



In addition to this normal training, he is required to undergo further training for which he may volunteer and which may from time to time be sanctioned by the Ministry of Defence, Government of India or by the State Government.

The uniforms issued to the cadets are to be used with care. Any loss or damage shall be made good by them.

National Service Scheme

The college has been allotted four units under National Service Scheme. Students from all classes can apply for this. They are required to put in 120 hours of work per year including a seven day camp. NSS volunteers who attend NSS camps regularly get an advantage over others in admission to postgraduate classes.



Identity Card is also necessary for participating in cultural and social activities and for claiming railway concession. If it is lost another can be got issued on payment of Identity Card Charges. Identity Card must be deposited back at the time of leaving the college. Students are expected to carry their identity cards with them to the college. From the previous academic session, the Identity Cards are being made in a more techno friendly manner with the practical application of Web Cameras, Pen Tablets for digital signatures of students, the quantity and quality of Identity Cards has improved for the better.

Ragging

"RAGGING IS COGNIZABLE OFFENCE AND IS BANNED IN ANY FORM INSIDE OR OUTSIDE THE COLLEGE CAMPUS"

As per the UGC letter No. F1-8/2006(CPP-II) dated February 2008 addressed to the Registrar, Panjab University, Chandigarh, Hon'ble Supreme Court of India has strictly banned ragging in Educational Institutions.

If any incident of ragging comes to the notice of the college authorities, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him/her from the institution.

Ragging includes disorderly conduct whether by words, spoken or written or by an act which has effect of teasing, treating and handling with rudeness any other student, indulging in rowdy or undisciplined activities which cause or are likely to cause hardship or psychological harm or apprehension to a fresher or junior student.

Generic Preventive Measures/ COVID-19 Appropriate Behaviour
